#### TYPE

A general purpose clean release agent for baking sheets and tins in a convenient easy to use aerosol can.

**Propellant: Butane and propane. Spray bottle should not be opened or damaged.**

**Highly flammable. Do not spray against open fire or hot surfaces.**

#### USAGE

Shake the bottle before use. Hold the bottle approx. 20 cm from the surface to be sprayed. Spray a very thin layer. Only for cakes with a high sugar content is a thicker layer needed.

Temperature must not exceed 50°C. Best spray performance when bottle is at room temperature.
