1000g Mix  
230g Water  
330g Oil  
365g Egg

- Mix with a beater for 1 min on slow speed.
- Scrape down.
- Mix for 4 minutes on medium speed.
- Deposit into loaf tin (360g)/cake pan.
- Bake at 180°C for 40 minutes.
